Criteria for Grant Applications

The foundation board will make its awards on the basis of what projects will best serve the greatest number of citizens within the greater Shenandoah area. Grant requests will be considered quarterly on the 4th Wednesday of January, April, July and October. Grant applications must be in the foundation office one week prior to the meeting.

If your grant request is approved, you will be notified and the funds will be dispersed upon verification of receipts. Also, where appropriate, the Board would like to receive confirmation pictures of items purchased or work completed.
